HSElife was created to address one of the main lessons of the tragic Warffum incident. The incident report revealed that there was insufficient knowledge of the dangers of working at an Oil & Gas location.

In the HSElife system, the hazards of different products and high-risk activities are explained in a simple way. There are also various training courses available to inform you about the dangers you may encounter on location.



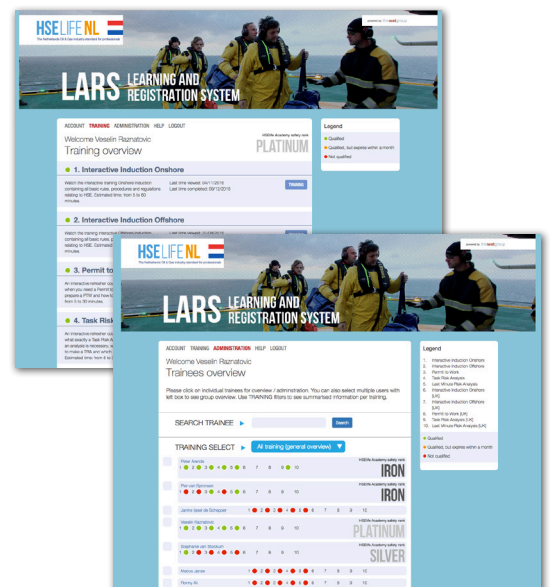
## WHY REGISTER?

**To register yourself is already a normal situation in our daily life. It is not difficult and gives a lot of possibilities. With HSElife we are now also taking this step and asking everyone to register in order to be able to do the training courses.**

HSElife keeps you informed when a training course is due and once every quarter you will receive the latest developments.

The "Learning and Registration System" (LARS), is 100% secure and protects your personal data. The designated persons will be able to see whether or not you have followed a training course.

Due to the registration process it makes it possible for companies to check if they have followed the correct training online. Our longtime goal is to abolish the PSL booklet and thus remove a lot of unnecessary administration, travel and waiting times. The system can communicate directly with your own Competence Management System.



# WHAT CAN I DO WITH THE HSE LIFE ACADEMY?

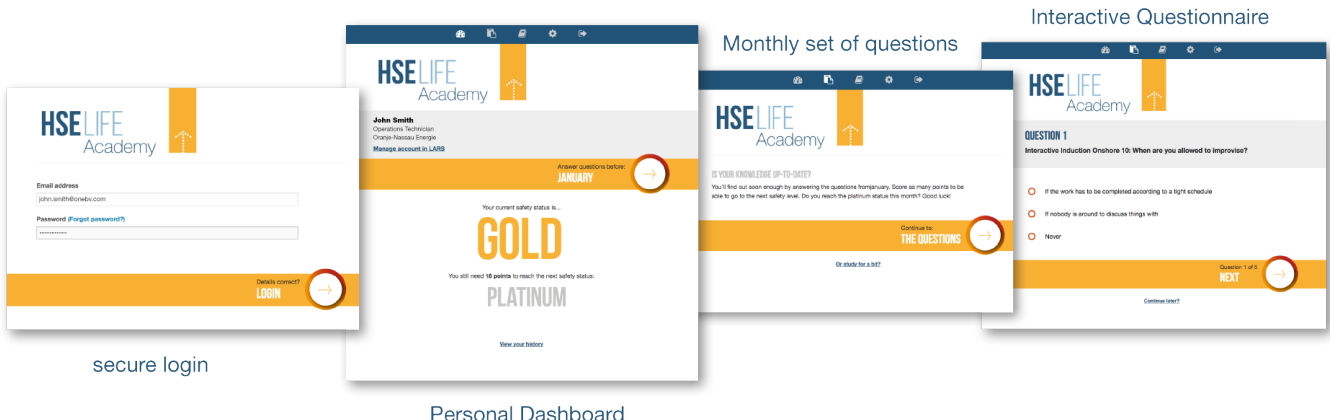
After introduction of VCA we are, supported by NOGEPa, taking the next step in increasing the knowledge of employees working in our industry with the HSElife Academy.

Employers are legally responsible for giving instructions. With this membership HSElife premium, the employer has a unique tool in hand to fulfill this responsibility.

After implementation of HSElife Academy, every employee will receive 5 questions to answer each month via the HSElife Academy, which he or she can easily access on any device (phone or iPad). By answering the questions, the person achieves or retains a level of knowledge (iron, bronze, silver, gold or platinum).

In recent years, the system has been intensively tested and put into operation by Oranje Nassau Energy (ONE), among others, both in the Netherlands and in England.

In order to be allowed to work for ONE, the GOLD level of knowledge is mandatory.





# CAN WE DO BETTER? LET US KNOW!

**There is always room for improvement, and that also applies to HSElife.**

**We regularly update the system and the information it contains, for example to meet changing legal requirements, as we did for example recently for Benzene.**

We also apply key lessons learned from incidents elsewhere in our industry. For example one of the lessons learned from an incident in the UK where it was discovered that natural gas condensate has a narcotic effect and inhalation can be fatal.
